1. CILJ PREDMETA The Aim of the Course	<p>Osim uvoda u etičku problematiku, odnosno modele etičkog razmišljanja koji proističu iz najvažnijih etičkih teorija, cilj predmeta je stjecajnje spoznaja o ključnim savremenim političkim debatama koje oblikuju savremenu političku zajednicu. S tim u vezi, studenti će biti upućeni na aktualne diskusije o ključnim aspektima i vrijednostima ethosa demokratskog društva, te temeljnim principima savremenog etičko-političkog diskursa i pozicioniranja etike u svakodnevnom političkom životu zajednice. U drugom dijelu predmet će studentima omogućiti uvid u ključne etičke probleme u oblasti međunarodnih odnosa.</p> <hr/> <p>Besides the introduction in basic ethical issues, that is in the models of moral reasoning springing out of the most important ethical theories, the goal of the course is to enable students to acquire basic knowledge on the key contemporary political debates that shape modern political community. Students will be referred to contemporary discussions on the key aspects and values of the ethos of democratic society, as well as to the fundamental principles of contemporary ethico-political discourse and the role of ethics in everyday political life of community. Specific dimension of the key ethical problems in the field of international relations will be included.</p>
